## Opening Statement

Dear President Donald J. Trump:

“We the people” of the United States of America, sign this petition in agreement with the writers of this petition, that the crimes of genocide must be charged against the ethnic White Latino and Mexican gangs who have willfully confessed that their intent is to ethnic cleanse and willfully destroy the so-called African American peoples AKA American Indians. The crimes that we charge them with fall under the act of genocide according to the present “Convention on the Prevention and Punishment of the Crime of Genocide”, which means any of the following acts committed in whole or in part, to a national, ethnical, racial or religious group, as such: (a) Killing members of the group; (b) Causing serious bodily or mental harm to members of the group; (c) Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part; (d) Imposing measures intended to prevent births within the group; (e) Forcibly transferring children of the group to another group."

According to the Federal Government and the Department of Justice, these acts have been going on for more than seven decades and is being called one of the “largest civil rights indictments in local history,” alleging that the gang members ruthlessly waged a race-fueled campaign against innocent African American families AKA, American Indian Original people—all with young children—to get them off their prized “turf”.

Despite the Federal Government and the Department of Justice’s efforts to put an end to these genocidal acts, we find that charging these criminals with civil rights’ indictments and other minor crimes is not enough to stop these systematic killings. Many of them get minimal sentencing and early parole, only to become repeat offenders. Therefore the only obvious course of action is to charge genocide.

### **Please Read the Following Text For More Clarification and Our Call to Action:**

America has always taken pride in proclaiming its strength and glory by way of its financial powers, and military might. These pillars once stood for the safekeeping of the American peoples—their right to exist and operate as a republic for which it stands as one nation—indivisible. And with that, each member of the U.S. Congress took an oath to solemnly swear to fight and defend our Constitution in order to form a more perfect Union, establish justice, insure domestic tranquility, provide for the common defense, promote the general welfare and secure the blessings of liberty to ourselves and our posterity, to ordain and establish this Constitution for the United States of America.

Let us remember, this Declaration was written as a formal explanation of why the Second Continental Congress voted to declare independence from the tyranny of Great Britain. The Declaration stressed two things: (1) Individual rights and (2) the right of revolution. However, on this very day, “We The People”

of America bear witness to a bipartisan tug-of-war between members of Congress who have become lax in their promise to maintain security and stability within this country; and by their actions we bare witness that this tug-of-war has weakened the very fabric of our National laws and the state of our Country by the tearing down of necessary social, political, economic and international borders that once kept us safe: But instead many of our voted in leaders have brought susceptibility to the American people wherein we are now influenced and controlled by outside forces who maintain a political and economic agenda that does not support the stability of America and the American People.

There was a time in this country when American leaders took pride to identify as Patriots who lived by and confessed that we are a “Nation Of Laws”, wherein Nativism was the policy that protected the interests of native-born Americans in regards to who we allowed into our land. And also, wherein, “We The People” have the right to proclaim our opposition to outside influences without fear of negative repercussions from our elected officials. But many of the same political factions who supported and believed in the strength and values of our American laws now ask “We The People” to decriminalize criminals who have and still willfully break our laws. And in our protest to such, our very own politicians push a Narrative that labels Americans who love the law as Xenophobic. And at the same time, leftist politicians have created a dangerous and deceptive narrative that pulls on the heartstrings of the American Indian Aboriginal people, wherein and where with, we ar asked to compare a four houndred years old holocaust and systematic disenfranchisement that our Negro ancestors endured with foreigners who are given Carte Blanch to take advantage of us and our children in our communities.

This leads us to ask a simple question: When did the Jews allow any other nation to compare and contrast to their holocaust? Perhaps the Jews know that these types of comparisons are dangerous. As we have found, other ethnic groups that we are expected to have compassion and empathy for have terrorized Americans with committed acts of genocide! For example, a most dangerous fact that liberal leftist politicians chose to omit from their comparative narration is that Mexican gangs are now the major drug distributors among our communities. And an even more dangerous fact is that Ethnic White Latino and Mexican gangs have waged a bloody campaign to drive the so-called “Blacks” from their neighborhoods.

These ethnic White Latino and Mexican gangs have willfully confessed that their intent is to ethnic cleanse and willfully destroy the so-called African American peoples AKA American Indian. These are acts of genocide according to the present Convention, of genocide which means any of the following acts committed in whole or in part, to a national, ethnical, racial or religious group, as such: (a) Killing members of the group; (b) Causing serious bodily or mental harm to members of the group; (c) Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part; (d) Imposing measures intended to prevent births within the group; (e) Forcibly transferring children of the group to another group."

## **THE CALL TO ACTION**

- Must be Categorized as acts of genocide as according to the laws of genocide
  - To publicize the Mexican War on America's Original Peoples
  - We demand Criminal record of offenses be kept open
    - i. This is why this is important to us.. Because these Mexican and Latino gangs have confessed to these acts.. Therefore It is unlawful to hide or change the act to keep it from being brought to light.. It should be categorized as Genocide and set to formal record.
  - Sentencing and Punishment must be carried out according to the laws of genocide.
- Call for immigration Laws to be enforced
  - Call to enforce the Antiterrorism and Effective Death Penalty Act (AEDPA) of 1996.
  - Call to initiate Illegal Immigration Reform and Immigrant Responsibility Act
  - immigration laws to protect the American original peoples and the lands
  - Call to Initiate protection laws
  - Sentencing and Punishment must be swiftly carried out according to the laws and protection against future genocide

## **Who Are The True Americans?**

### Noah Webster's Dictionary 1828

Defines American as,

AMER'ICAN, adjective Pertaining to America.

AMER'ICAN, noun A native of America; originally applied to the aborigines, or copper-colored races, found here by the Europeans; but now applied to the descendants of Europeans born in America.

According to the 1828 definition above from Noah Webster’s Dictionary, the title of “American” only applies to two people in this country: (1) The “copper-colored” American Indian Aborigines who have been relabeled “Negro”, “Colored”, “Black”, or “African-American” and (2) the descendants of Europeans born in America. Based on this definition alone, this debunks any argument defending the allowance of foreigners and their descendants to claim the title.


## Harriet Beecher Stowe's Account On The American Race

There are many early documents describing the Phenotype of the CCA prior to European invasion. Harriet Beecher Stowe, author of the famed "Uncle Tom's Cabin" (1853), describes in detail the phenotype of the CCA in her book "Primary Geography for Children, On an Improved Plan" (1833):

islands, together with Australasia and Polynesia, are inhabited by the Malay race.

These people are different from the American, in having a brown, instead of a copper-colored skin; and in having soft, curly, black hair, instead of straight and coarse. Many of the Malay race are handsome, for their complexion often is not darker than some of the darkest ones in our country.

The African race have black, woolly hair, and black skin. They live principally in the middle parts of Africa. Here are pictures of an African and an American.



All the rest of the countries of Asia are inhabited by the Asiatic race. These people have dusky, yellowish skins, of the color of dried
